KCH is the holding company for nine Majority State Owned Enterprises (SOE) operating across a broad range of sectors in PNG and included in these SOEs is Kumul Telikom Holdings Limited (KTHL) and under KTHL is PNG DataCo.

PNG DataCo was established in 2014 and is responsible for all wholesale infrastructure capacity with access to submarine and onshore fibre cable and satellite infrastructure. The company is the lead implementing agency for the new domestic and international submarine cables which will deliver revolutionary bandwidth capacity to PNG, within the next 18 months. These projects represent an investment in excess of USD350m.

PNG DataCo is managing the implementation of new domestic submarine fibre capacity. The company is also managing the PNG component of the new Coral Sea Cable System submarine cable between PNG, SI and Australia.
